

Surface Preparation

Surfaces must be clean, dry, and free of frost, damage and all bond-inhibiting materials, including dirt, efflorescence, form oil and other foreign matter. Damaged sheathing must be removed and replaced. Avoid application over irregular surfaces. Substrate to be coated must be continuous without joints, holes, etc. exceeding 1/8" (3 mm) in size. Sheathing must be properly installed as required by applicable building codes or sheathing manufacturer.

Application

Apply only to sound and clean, dry, properly prepared, frost-free surfaces with a stainless-steel trowel.

Glass Mat Gypsum, OSB Exposure 1, and Exterior Grade Plywood: Treat joints with StoGuard Mesh centered over the joints and coat the mesh evenly with Sto Gold coat TA. Alternatively use any other StoGuard® joint treatment. Protect rough openings with Sto Gold Coat TA applied over StoGuard Mesh. Refer to Sto Detail 10.23a. Alternatively use any other StoGuard® rough opening protection. Spot surface defects such as overdriven fasteners, knots or other voids in sheathing surface with Sto Gold Coat TA prior to full application. When dry coat the entire wall surface, INCLUDING JOINT TREATMENTS AND ROUGH OPENING PROTECTION, with an even coat of Sto Gold Coat TA at 26-40 WFT (20-30 DFT) or Sto Gold Coat at 10-12 WFT (5-7 DFT) to produce a VOID AND PINHOLE FREE SURFACE. Wood-based sheathing may require touch-up to completely cover the surface.

Sto Gold Coat TA is a readymixed flexible trowel applied air and moisture barrier for use in StoTherm® ci Systems. It is applied directly to vertical above grade wall sheathing, concrete, and concrete masonry.

Application cont.

Concrete Masonry: Repair cracks up to 1/4 inch (6 mm) wide by filling with Sto RapidGuard. Rake the crack with a sharp tool to remove loose or friable material, and blow clean with oil-free compressed air. Apply Sto RapidGuard with knife or spatula over the crack and smoothen. For wider cracks or moving cracks consult a structural engineer. Do not use Sto RapidGuard to repair moving cracks or cracks wider than 1/4" (6 mm). Protect crack repair materials from rain and freezing until dry.

IMPORTANT: Sto Gold Coat TA functions as an air and moisture barrier on normal weight concrete masonry unit wall construction with flush (struck flush with the surface of the CMU) or concave joints when a minimum of two liberal coats are applied. Additional coats may be necessary depending on the condition of the CMU wall surface, CMU porosity, joint profile, and other variables that may exist. For "rough" CMU wall surfaces, skim coat the entire surface with one of Sto's cementitious levelers (Sto Leveler, Sto BTS® Plus, Sto BTS® Silo, Sto BTS® Xtra or Sto Primer/Adhesive-B) before application of

Sto Gold Coat TA. Apply Sto Gold TA at 26-40 WFT (20-30 DFT). A VOID AND PINHOLE FREE SURFACE must be achieved for Sto Gold Coat TA to properly function as an air barrier and moisture.

Concrete: Repair cracks as described for concrete masonry and allow crack repair to dry. Apply a uniform coat of Sto Gold Coat TA at 26-40 WFT (20-30 DFT) to produce a VOID AND PINHOLE FREE SURFACE.

Curing/Drying

Sto Gold Coat TA is dry to touch and can be over coated within 2-4 hours under normal conditions (70°F [21°C], 50% RH). Wait 24 hours minimum before adhesive attachment of Sto insulation board. Final drying varies depending on temperature/ humidity, thickness of application, and surface conditions. Hot, dry conditions accelerate drying. Cool, damp conditions retard drying and may require extended periods of protection. Protect from rain and freezing until completely dry.

Clean tools and equipment with water immediately after use. Dried material can only be removed mechanically.

Limitations

- Sto Gold Coat TA is a water based product. Apply only when surface and ambient temperatures are 40°F (4°C) and rising. Maintain temperatures above 40°F (4°C) during drying period for at least 24 hours.
- Do not use on damp surfaces, below grade, or on surfaces subject to water immersion.
- Fire-retardant treated or pressure treated plywood substrates must be dry and free of all bond-inhibiting materials.
- Not recommended for spanning sheathing joints or holes in excess of 1/8" (3 mm). Joints must be properly reinforced with StoGuard joint treatment.
- Provide adequate ventilation during application and drying period. Ventilate temporary heaters to the exterior to prevent water vapor from accumulating on or within the wall assembly materials.
- Ensure the Sto Gold Coat TA surface is clean, dry, and free of surface contamination. Install StoTherm ci insulation board within 30 days of the application of Sto Gold Coat TA, or clean the surface and recoat with Sto Gold Coat TA.



Substrate to be coated must be continuous without joints, holes, etc. exceeding 1/32" (0.8 mm) in size. Sheathing must be properly installed as required by applicable building codes or sheathing manufacturer.

Application

Apply only to sound and clean, dry, properly prepared, frost-free surfaces.

Installation over Sheathed Wall Construction:

Place minimum 4 inch (101 mm) wide mesh at sheathing joints and minimum 9 inch (152 mm) wide mesh at rough openings and inside and outside corners (refer to Sto detail 20.23a). Immediately apply Sto Gold Fill by spray or trowel, or Sto Gold Coat TA by trowel, over the mesh and trowel smooth. Protect from rain and freezing until dry.

For waterproofing, apply one of the StoGuard air and moisture barrier products to sheathing and all areas where StoGuard Mesh has been top-coated with Gold Fill or Gold Coat TA. See StoGuard product literature (specifications, product bulletins, etc.) for more information.
