

# **Surface Preparation**

#### Concrete and masonry surfaces:

Surfaces must be free of all bond-inhibiting materials, including dirt, efflorescence, form oil and other foreign matter. Loose or damaged material must be removed by water blasting, sandblasting or mechanical wire brushing and repaired.

Avoid application over irregular surfaces.

Resurface, patch or level surfaces to required tolerance and smoothness with appropriate Sto leveling materials. Refer to ASTM D-4258 and ASTM D-4261 for complete details on methods of preparing cementitious substrates for coatings.

Sto Stucco Finisher is a ready mixed, elastomeric textured wall coating used as a decorative and protective wall coating over prepared, vertical, above-grade concrete, masonry and plaster/stucco substrates.

### Coverage

Sto Stucco Finisher Fine: 175-200 ft² (15.75-18 m²) per pail. Sto Stucco Finisher Medium: 140-175 ft² (12.6-15.75 m²) per pail.

Sto Stucco Finisher Swirl: 150-180 ft<sup>2</sup> (13.5-16.2 m<sup>2</sup>) per pail.

Coverages may vary depending on application technique and surface conditions.

### **Packaging**

5 gallon pail.

## Shelf Life

18 months, if properly stored and sealed.

#### Storage

Protect from extreme heat, freezing and direct sunlight.



# Sto Stucco Finisher

# Mixing

Mix with a clean, rust-free electric drill and paddle. A small amount of clean water may be added to aid workability. Limit addition of water to amount needed to achieve the finish texture.

### Application

Apply only to sound, clean, dry, properly prepared, frost-free surfaces. Apply Sto Stucco Finisher with a clean stainless steel trowel to a rough thickness slightly more than the largest aggregate size. Use the trowel to scrape the material down to a uniform thickness no greater than the largest aggregate size. Achieve final texture by floating with the appropriate trowel in a figure-eight motion; stainless steel trowel for Sto Stucco Finisher Fine or Medium (pebbled texture finishes) and plastic float for Sto Stucco Finisher Swirl (rilled texture finishes). Once applied, the working time is up to 20 minutes depending upon material, ambient temperatures and surface conditions.

IMPORTANT: ALWAYS check color for proper match. If color does not match, STOP- call your Sto representative. For best results always prime cementitious substrates. Apply coating in a continuous application, always working from a wet edge or architectural break to eliminate cold joints. Minor shade variations may occur from batch to batch (refer to batch no. on pail). Avoid

installing separate batches side-by-side and avoid application in direct sunlight. Avoid installing new finish adjacent to weathered or aged finish. Sto Corp. will not be responsible for shade or color variation from batch to batch, variation caused by application or substrate deficiencies, or fading resulting from natural causes such as weather. See Tech Hotline Nos. 0694-C, 0893-EC and 1202-CF for helpful tips on prevention of color problems. Protect installed product from rain, freezing, and continuous high humidity until completely dry.

EIFS: select colors with a lightness value of 20 or greater.

### Curing/Drying

Sto Stucco Finisher dries overnight under normal conditions [70°F (21°C), 50% RH]. Drying time varies with temperature/humidity and surface conditions.

### Clean Up

Clean tools and equipment with water immediately after use. Dried material can only be removed mechanically.

### Limitations

- Use Sto Stucco Finisher only when surface and ambient temperatures are above 40°F (4°C) during application and drying period.
- Sloped surfaces: minimum required slope is 1:2 (27°) and maximum width is 12" (300 mm). Sto Mesh embedded in Sto Flexyl is required beneath finish coating. Increase slope for northern climates to prevent accumulation of ice/snow and water on surface.
- Sto Stucco Finisher should not be used on horizontal, below grade or water immersed surfaces.
- Periodic inspection and increased maintenance of coating may be required.
- Application of Sto Stucco Finisher below grade is not recommended. Sto Stucco Finisher is not recommended over interior wall surfaces.
