- 2] Install extruded vinyl joints as per manufacturers recommendations. Set joint intersections and terminations in sealant to prevent water penetration behind the joint.

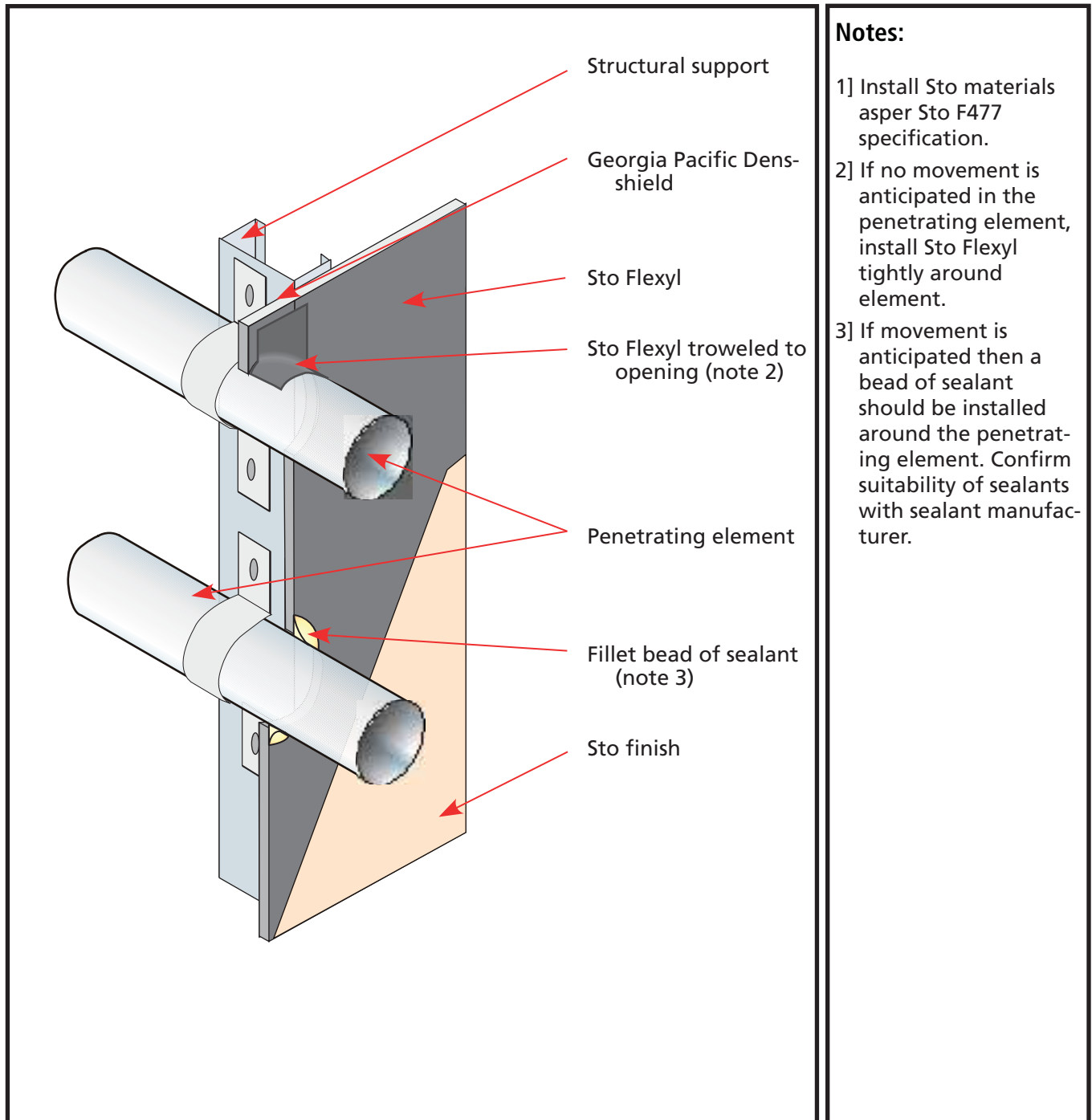
